

Order.02	23.01.2023	<p>Petitioner present through attorney and counsel.</p> <p>Argument heard and case file perused.</p> <p>Perusal of case file reveals that the instant petition instituted by the petitioner for appointment as legal guardian for the person and properties of the minors namely <b>Shakir Ullah and Muhammad Azeem Ss/o Eidam Shah</b> mentioned in the petition on the grounds that the petitioner is the real paternal cousin of the minors.</p> <p>The respondent/general public was summoned through publication in newspaper "Daily Ausaf" dated: 16.10.2022, however none turned up as legal guardian of the minors other than the petitioner. Therefore, the respondent proceeded ex-parte. Consequently, petitioner produced ex-parte evidence.</p> <p>The petitioner/ward produced the minors namely Shakir Ullah and Muhammad Azeem Ss/o Eidam Shah and their statement is recorded. The Shakir Ullah and Muhammad Azeem produced their CNIC/smart card/student card which are Ex.PA and Ex.PB respectively wherein, they stated that they have no objection if the petitioner/ward namely Manzoor Ullah is appointed as their guardian. It is evident that minors are residing presently with the petitioner, who is looking after them. As real paternal cousin, he is most likely to take care of the welfare of the minors.
