


<p>Order .04 Continued</p>	<p>23.01.2023</p>	<p>At this stage there seems to be no clash of interest between the minors and the petitioner, being a real mother of the minors, in the light of statements of witnesses produced by the petitioner. It is evident that minors are residing presently with the petitioner, who is looking after them. As real mother, she is most likely to take care of the welfare of the minors. Therefore, the petition in hand is accepted under Section-07 of Guardian & Wards Act, 1890 and petitioner is appointed as guardian of the person of the above minors having generally the rights, duties and liabilities of a guardian mentioned in the Guardian & Wards Act, 1890 and subject to the following conditions especially in view of section-34 of the said Act.</p> <ul style="list-style-type: none">• <i>That she will produce the minors in court as and when required by the court.</i>• <i>That she will maintain and educate the minors in proper manner.</i>• <i>That she will not take away the minors outside the jurisdiction of this court without prior permission.</i>• <i>That she will not act in prejudice to the interest of minors.</i>• <i>That she will not be entitled to dispose of the property of minors without prior permission of the court.</i> <p>Original guardianship certificate be given to the petitioners' subject to surety bonds while copy of the certificate be placed on file.</p> <p>File be consigned to the record room after its necessary compilation and completion.</p> <p><u>Announced</u> 23/01/2023</p> <p> (Rehmat Ullah Wazir) SCJ/Succession & Guardian Judge, Orakzai (Baber Mela)</p>
