



This is the disposal of Pre arrest bail application presented by accused/petitioners Shamal Hassan son of Tamash Ali, Maqbool Hassan son of Shamal Hassan and Gul Hassan son of Shamal Hassan, residents of Kamangar Kalaya Orakzai.</p> <p>3. Zeenat Ali complainant, charged the accused/petitioners Shamal Hassan, Maqbool Hassan and Gul Hassan for his wrongful confinement. The Roznamcha Madd No. 9 was converted into FIR bearing No.113 dated 30-10-2022, registered at Police Station, Kalaya under Section 342/34 of the Pakistan Panel Code, 1860. The accused presented instant pre-arrest bail petition, which is under consideration.</p> <p>4. Arguments of counsel for the accused/petitioners and APP for State heard and record perused.</p> <p>5. On tentative assessment of record, it reveals that petitioners have specifically been mentioned in the contents of FIR. Neither mala fide nor intention to disgrace, humiliation, harassment and dishonor on part of the complainant or prosecution is being surfaced.</p> <p>6. For what has been discussed above, instant pre arrest bail petition stands dismissed. Ad-interim pre arrest bail earlier granted to the accused/petitioners is hereby recalled.</p> <p>7. File of this Court be consigned to District Record Room after its necessary completion and compilation within the span allowed for; whereas, copy of this Order be placed on record of Police to be returned accordingly.</p> <p>8.
