- This is tentative assessment of record available on 5. file as deep appreciation is neither required nor warranted at this stage of bail. The accused/petitioner was allegedly carrying chars in white sack measuring 9900 grams left behind while escaping from the spot; but, no private witness has been associated with the recovery proceedings. The petitioner has been nominated on pointation of accused arrested on the spot but there is no sketch of the accused recorded during the investigation despite being claimed to be seen on the spot. Similarly, no identification parade has been conducted after arrest of such accused. Recovery has not been made from direct possession of the petitioner nor has he been arrested on the spot. The report of the Forensic Science Laboratory is still awaited and determination of the recovered material as chars is pre mature. More so, the prosecution is also not claiming that the accused was previously involved in the same nature of cases. All these facts renders the case of petitioner as one of further inquiry.
- 6. For what has been discussed above, instant bail petition stands allowed subject to furnishing bail bonds to the tune of Rupees 150,000/-; with two sureties, each in the like amount; to the satisfaction of this Court.
- 7. File of this Court be consigned to District Record Room after its necessary completion and compilation within the span allowed for; whereas, copy of this Order be placed on record of Police to be returned accordingly.
