## SUMMARY JUDGEMENT 20.02.2023

Attorney of plaintiff present. He produced attested school record/extract of admission & withdrawal register and certificate issued by principal G.G.H.S.S, Kurez, Orakzai which is placed on file. Representative of defendants also present. Written statement along with NADRA record submitted. He stated that he has got no objection on the summary disposal of the case on the basis of available record. Arguments heard and record perused.

Brief facts in the backdrop are that plaintiff has filed the instant suit for declaration cum-permanent injunction to the effect that, as per school record, her true and correct date of birth is **09.02.2008**, however, defendants have incorrectly entered the same as

**04.08.2004** which is wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That defendants were asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.

With due process of law and procedure, the defendants were summoned, they appeared through representative. Authority letter and written statement was filed.

Plaintiff has placed reliance on Middle School Certificate issued by Government Girls High School, Kurez. Representative of defendants stated that date of birth of plaintiff may be modified as per school record per NADRA SOPs. As per attested extract of admission & withdrawal register and school certificate, date of birth of plaintiff is recorded as 09.02.2008. There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff as 09.02.2008 accordingly. Suit of plaintiff is hereby decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any.
