

All the exhibited documents, publication and report of process server etc. are placed on file. Contents of the petition were reproduced and verified by the witnesses.

The available record on file prima facie establishes that petitioners are the legal heirs of deceased Mst Shughla Jan as there is nothing in rebuttal. Hence, petitioners will inherit the legacy of deceased as per following shares;
