,		3. Deputy Commissioner of the District Orakzai, charged the
-		accused/petitioners for using fake documents and signing the
		Domicile Certificates illegally on behalf of the District
		Administration Orakzai for getting admission in MBBS on reserved
		seat of District Orakzai. Letter of the Deputy Commissioner, Orakzai
		dated 26-01-2023 was converted into FIR bearing No.06 dated 31-
		01-2023, registered at Police Station, Central Mishti Mela under
		sections 420/471/468 of the Pakistan Panel Code-1860. The above
		named petitioners presented instant pre-arrest bail petition, which is
		under consideration.
		4. Arguments of counsel for the accused/petitioners and APP for
		State heard and record perused. Counsel for the petitioners submitted
		an application for addition of section 471 instead of section 463 in
	·	the petition which was later on inserted in the FIR by the prosecution.
		Application allowed and same correction made in the petition.
,		5. On tentative assessment of record, it reveals that petitioners have
,		specifically been named in the contents of FIR. Neither mala fide nor
		intention to disgrace, humiliation, harassment and dishonor on part of
		the complainant or prosecution is being surfaced.
		6. For what has been discussed above, instant pre arrest bail
		petition stands dismissed. Ad-interim pre arrest bail earlier granted to
		the accused/petitioners mentioned above is hereby recalled.
		Petitioners or their authorized agents are at liberty to withdraw the
		cash amount deposited with Civil Nazir in line with section-513 of
		the Code of Criminal Procedure, 1898.
