

It be registered.</p> <p>Accused, Mehboob and Gul Zaman are charged in case FIR No. 101, dated 10.08.2021, u/s 302/34 PPC of Police Station Kalaya, wherein, as per contents of FIR, the complainant on 10.08.2021 made a report to the local police to the fact that on that day his brother was working on road of NGO Project outside the house, in the meanwhile, accused Mehboob and Gul Zaman opened fire on them due to which his brother deceased Sanat Ullah hit on head and died on the spot.</p> <p>The accused, despite being proceeded u/s 204 Cr.P.C and 87 Cr.P.C, failed to appear. Hence, they were proceeded u/s 512 Cr.P.C. The court of learned Judicial Magistrate, after recording the statements of as many as nine (09) PWs, has sent the file to the court of Hon'ble the District & Sessions Judge, Orakzai for issuance of perpetual warrants, which, was entrusted to this Court.</p> <p>It is evident from the record that the above-named accused are deliberately avoiding their lawful arrest and there is no probability of their arrest in near future; hence, as per record, a prima facie case exists against the</p>
