SUMMARY JUDGEMENT

20.03.2023

Plaintiff No. 2 along with counsel present. Representative of defendants present. Learned counsel for plaintiffs requested for summary disposal of the suit. Representative of defendants stated that per NADRA SOPs, date of birth of a person can be modified/rectified if there is unnatural age gap between parents and children. Arguments heard and record gone through.

suit for declaration cum-permanent injunction against the defendants Chairman NADRA, Islamabad and two others to the effect that, true and correct date of birth of plaintiff No. 1 is 01.01.1973, however, defendants have incorrectly ZAHIR KHAN entered the same as 01.01.1985. Similarly, the correct date of birth of plaintiff Civil Judge/JM Kalaya Orakz No. 2 is 01.01.1973, however, defendants have incorrectly entered the same as

02.10.1979, which entries are wrong, illegal and ineffective upon the rights of

plaintiffs and liable to be rectified. That due to this wrong entry, there is unnatural age difference of about 06 years between plaintiff No. 1(mother) and her daughter namely Azmina Jan. Similarly, there is unnatural age difference of about 12 years between plaintiff No. 2 (father) and his daughter named above. That defendants were asked time and again to rectify date of birth of plaintiffs but in vain hence, the present suit.

Representative of defendants stated that there shall be at least 17 years' age difference between children and their parents. Per record, date of birth of plaintiffs are recorded as 01.01.1985 and 02.10.1979 respectively resulting into unnatural age difference of about 06 between plaintiff No. 1 (mother) and her daughter. Similarly, there is age difference of about 12 between plaintiff No.2 (father) and his daughter. Plaintiffs are not government servants. The modification sought by plaintiffs will not affect rights of others. Representative of defendants stated that date of birth of plaintiffs may be modified as per NADRA SOPs. There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff No. 1 and plaintiff No. 2 as 01.01.1973. Suit of plaintiffs is decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any. This decree shall not affect service record of plaintiffs, if any.
