## SUIT FOR DECLARATION, CUM PERPETUAL AND MANDATORY INJUNCTION

### **SUMMARY JUDGEMENT:** 22.03.2023

Akbar has brought the instant suit for declaration cum perpetual and mandatory injunction against the defendants, referred hereinabove, seeking declaration therein that his correct date of birth is 1972 according to his Service Record wazlk. Medical Certificate whereas, it has been wrongly mentioned as 1963 in the record of defendants, which is wrong, ineffective upon the rights of the plaintiff and is liable to correction. That the defendants were asked time and again for correction of date of birth of the plaintiff but they refused to do so, hence the present suit;

- Defendants were summoned, who appeared through their 2. representative namely Mr. Irfan Hussain, who submitted written statement.
- During the scheduling conference within the meaning of 3. order IX-A of CPC, it was revealed that the matter involved in the instant case is very petty in nature, which can be decided through summary judgement as per relevant record. To this effect notice was given to the parties that why not the case in hand be decided on the basis of available record without recording lengthy evidence, as the primary aim and objective of Amended Management Rules in CPC is, "to enable the court to-

Deal with the cases justly and fairly;

Licourage parties to alternate of the considers appropriate;

LAH WAZIR procedure if it considers appropriate;

The concerned record-keeper of District Police, Orakzai was summoned and the one Atif Ullah appeared as CW-01 who produced Service Record, District Police, Orakzai and Medical Record of the plaintiff, the copies of which are Ex.CW-1/2 and Ex.CW-1/3 respectively and that according to these, the date of birth of the plaintiff is 1972.

Learned counsel for plaintiff and representative defendants heard and record gone through.

- Record reveals that plaintiff through instant suit seeking declaration therein that that his correct date of birth is 1972 according to his Service Record and Medical Certificate whereas, it has been wrongly mentioned as 1963 in the record of defendants, which is wrong, ineffective upon the rights of the plaintiff and is liable to correction. Plaintiff in support of his contention produced his Service Record and Medical Certificate, wherein the date of birth of the plaintiff has been mentioned as 1972, So, Service Record and Medical Certificate of the plaintiff clearly negate the incorporation of his date of birth as 1963 in record of the defendants. Further, there is no countered document available with the defendants to rebut the document produced by the plaintiff in support of his stance, which establishes that the date of birth of the mantiff has wrongly been mentioned in record of the defendants that is against the facts and circumstances. The available record is sufficient to decide the fate of the case
- 6. Consequently, upon what has been discussed above and the jurisdiction vested in this court under order IX-A and XV-A of CPC, suit of the plaintiff succeeds and is hereby decreed as prayed for with costs. Defendants are directed to correct

and no further evidence is required to be produced by the
