Perusal of record shows that accused namely Aizaz Hassan S/O Naseem Hassan R/O Marai Payan, District Kohat is charged in the above cited case for the commission of the offence U/S 5-EXP SUB ACT, registered at PS Kurez Boya. Accused was released on bail but he disappeared when the trial commenced, resultantly, bail bonds of the accused were forfeited to the state and proceedings u/s 512 Cr.PC were initiated vide order dated 20.09.2022.

Prosecution was allowed to produce its evidence within the meaning of Section 512 Cr. PC. Prosecution produced 04 witnesses.
