

(2) Since investigation in the instant case is complete and the motorcycle in question is no more required for further investigation besides the petitioner has produced documents regarding the same which prima facie reveals his ownership of the motorcycle in question and more so at the moment, there is no rival claimant as well as the same is not involved/required in any other case.

(3) Therefore, the petition in hand is accepted and the motorcycle in question is hereby return to the petitioner on bail with sum of Rs. 50,000/- with two sureties, each in the like amount to the satisfaction of this court. However, the petitioner shall be bound not to dispose of the motorcycle till further orders and will produce the same as and when required.
