**ORDER**



Accused/petitioners on ad-interim pre-arrest bail with their counsels present. Mr. Javid Iqbal Anwar Sr.PP for the State present. Mst: Rohtaj Bibi (Sister of deceased Abdul Ghafar) present in person.

This consolidated order is intended to disposed of the above titled pre arrest bail application submitted by accused/petitioners Sultan Shah s/o Kalam Shah and Hazrat Ameen s/o Gul Chamand r/o District Orakzai for their confirmation of their ad-interim pre-arrest bail in case FIR No.39 dated 12/09/2020 U/Sec 302/34 PPC of PS Upper District Orakzai wherein the accused/petitioners are charged for the murder of Abdul Ghafar deceased.

Today Mst: Rohtaj Bibi, the sister of deceased Abdul Ghafar present before the court and submitted affidavit of compromise and stated that she is the sister of deceased Abdul Ghafar and is the sole surviving legal heir of deceased and the deceased was unmarried. She stated that she has pardon the accused/petitioners in the name of Al mighty Allah and have waived of her right of Qisas and Diyat. She has got no objection if the ad-interim pre-arrest bail of both the accused/petitioners is confirmed. The Statement of Mst; Rohtaj Bibi recorded before the court and placed on file. The affidavit of compromise is Ex.PA and her copy of CNIC is Ex.PB.

The legal heir of deceased Mst: Rohtaj Bibi is the wife of accused Hazrat Ameen and daughter of accused Sultan Shah and the compromise



between the parties is genuine which shall bring peace and harmony between them. The offence is compoundable and the sole legal heir has affected compromise therefore in the best interest of justice the compromise is accepted and the bail petition in hand is accepted on the basis of compromise and the ad-interim pre-arrest bail granted to the accused/petitioners vide order dated 19/10/2020 and dated 28/10/2020 is hereby confirmed on the strength existing bail bonds.
