



Order No.04</p>		<p>Ghiljo, wherein as per contents of FIR, Tajmeen Khan ASHO vide Daily Diary No. 11 of 13.04.2023 made a report to the police to the fact that on that day he along with Moharrir Abdul Manan were present at Ghiljo Bazar when the accused/petitioners came there, trespassed the police station and criminally intimidated constable Hameed Ullah. Hence, the present FIR.</p> <p>At the very outset, Naseem Khan, the SHO of Police Station Ghiljo and constable Hameed Ullah submitted that they have patched the matter with the accused/petitioners with the permission of their high-ups, forgiven them in the name of Almighty Allah and they have got no objection on the confirmation of pre-arrest bail of the accused/petitioner or their acquittal at trial stage. To that effect, their joint statement is recorded and placed on file.</p> <p>Hence, on acceptance of the compromise, the instant BBA petition is allowed. The ad-interim pre-arrest bail allowed to the accused/petitioners vide order dated 18.04.2023 of this court is confirmed on the strength of existing bail bonds.
