


Order No.02	22.05.2023	<p>DPP, Umar Niaz for State present. Accused Munir Khan on bail, not present. The prosecution submitted application for discharge of accused. Arguments on application heard.</p> <p>Accused Munir Khan s/o Risham Khan is charged for the offence u/s 9 (d) of the Khyber Pakhtunkhwa Control of Narcotic Substances Act, 2019 vide FIR no. 16, dated 11.02.2022 of Police Station Kalaya, wherein, as per contents of FIR, the complainant Younas Khan SHO acting on information regarding smuggling of narcotics by accused Munir Khan and Sarhad through Manzakhe road to Bara Khyber, laid a picket on the spot, where at about 1530 hours the above-named persons riding a motorcycle without registration number, on seeing the police party, abandoned the motorcycle along with two bags and made their escape good from the spot. Accordingly, he was summoned but the accused did not turn up before the court. Thereafter, the prosecution submitted application for discharge of the accused on the grounds mentioned therein.</p> <p>It is evident from the record that neither the accused was arrested on the spot nor any recovery has been effected from his personal possession. There is nothing available on file to show that as to how the local police was able to establish the identity of the accused named above.</p> <p>Hence, in view of what is discussed above, it is held that there is no ground to proceed against the above-named accused; therefore, on acceptance of the application of prosecution, the accused named above is discharged of the offence.
