## ORDER No. 04

23.05.2023

DPP, Umar Niaz for State present. Accused Muhammad Ali is absconding.

- (2).Arguments heard and record perused.
- **(3)**. The case of the prosecution as per Murasila Ex. PA based FIR Ex. PA/1 is; that on 16.03.2023 the complainant Hassan Jan SHO/PW-1 along with constables Syed Abbas Ali, Junaid Ali and Khalid Ali/PW-2 during routine patrolling in official vehicle were present on the spot, where at about 1500 hours a person walking on foot from fields towards the main road having a white colour bag on his shoulder, on seeing the police party threw the bag and made his escape good from the spot. The search of the bag led the complainant to the recovery of 13 packets of chars, wrapped with yellow colour scotch tape, each on 1000 grams, making a total of 13000 grams while empty sack came out 33 grams. The complainant/PW-1 separated 10 grams of chars from each

packet for chemical analysis through FSL, packed and sealed the same into parcels no. 1 to 13 whereas the remaining quantity of chars weighing 12870 grams along with the empty bag were sealed in parcel no 14, by affixing monogram of 'HK' on all parcels. The complainant/PW-1 took into possession the recovered chars vide recovery memo Ex. PW 1/2. Murasila Ex. PA was drafted and sent to the Police Station through constable Khalid Ali/PW-1 which was converted into FIR Ex. PA/1 by Intikhab Ali AMHC/PW-3. The absconding accused Muhammad Ali s/o Sharif Khan was charged for the commission of offence on the basis of information.

- (4). After completion of investigation, the prosecution submitted challan against the absconding accused Muhammad Ali who was proceeded u/s 512 Cr.P.C and the prosecution was directed to produce evidence in absentia of the accused. Accordingly, the prosecution produced and examined as many as 05 witnesses.
- proceeded u/s 204 Cr.P.C as well as u/s 87 Cr.P.C, the accused is avoiding his lawful arrest and there is no likelihood of his arrest in near future. As per evidence recorded by the prosecution, a prima facia case has been made out against the absconding accused Muhammad Ali s/o Sharif Khan; hence, he is declared proclaimed offender. Perpetual warrant of arrest be issued against him and DPO Orakzai is directed to enter his name in the register of proclaimed offenders. All the legal course be adopted for his arrest and he be brought before the court as and when arrested. Consign.
