Petitioners present through counsel and attorney.
 Arguments heard and record perused.



- 2. Through publication in daily newspaper "Ausaf" dated; 9th Oct, 2020 general public was asked to submit objections, if any, however, no one appeared before the court, so ex-parte proceedings were conducted.
- 3. Petitioner No. 01. Mst Maan Gula (widow), 02. Sahaina Bibi (Daughter), 03. Samana Bibi (Daughter) 04. Zahid Rehman (Son) 05. Majeed Rehman (Son) 06. Mst Bibi (Widow) 07. Wahib Rehman (Son) 08. Nabi Rehman (Son) 09. Azmeena Jana (Daughter) 10. Roomina Bibi (Daughter) 11. Raheem Bibi (Mother) filed the instant application. Nabi Rehman (attorney) recorded his statement as PW-1, Muhammad Aftab as PW-2 and Shahid Khan as PW-3 testified respectively.
