## Order No. 02

DPP, Umar Niaz for the State present. Juvenile Accused Haider Aziz on bail present in person. Mr. Sana Ullah Advocate submitted Wakalatnama for the accused in the connected case no. 17/2 of 2020 titled "State VS Sartaj Aziz". Complainant Muhammad Tariq also present and submitted an application in the above cited connected case for the disposal of the case on the basis of compromise arrived at between the parties at the bail stage. Statement of the complainant to this effect also recorded and placed on file in the above titled case.

In the instant case, complainant through case FIR no. 56 dated 06.06.2020 U/S 324/34/337-A (iii)/337-A (i) PPC of PS Lower Orakzai Kalaya wherein he has reported against the accused facing trial of the connected case, namely Sartaj Aziz and Juvenile accused Haider Aziz sons of Aziz Ur Rehman of the present case for causing injuries to him and his cousin Sajid Khan by means of firearm. During the stage of pre-arrest bail, the complainant party has submitted a compromise before the Court of ASJ-II, Orakzai wherein they deposed that the matter between them have been patched up and they have forgiven the accused in the name of Almighty Allah, hence, they raised no objection either on the acceptance of the bail petition of accused or upon their acquittal during the trial. The attested copies of the compromise produced today before the present Court are Ex. P1 consist of four pages, which compromise was stated still intact and on the basis of same, complainant requested for the disposal of the case. The attested copies were placed on file in the above cited connected case.

(3). Since, the sections of law levelled against the accused facing trial are compoundable and the attested copies of the compromise as well as the bail order produced and placed on file in the connected case today reveals that a genuine compromise has been affected between the parties which is still intact and nothing is outstanding against them. Therefore, the above-named accused facing trial on the basis of said compromise stand acquitted from the charges levelled against him through FIR in question. Bail bonds of the accused stand cancelled and sureties of the accused stand discharged from the liability of bail bonds. Case property, if any, be disposed of in accordance with law but after period provided for appeal/revision.
