- 1. Accused Gul Nawaz and Amir Nawaz, both sons of Muhammad Yousaf; residents of Mishti Mela Bazar Orakzai have been summoned to face trial in case FIR No.34 dated 01-05-2020 u/s 324/34 PPC of PS Lower Orakzai.
- 2. The allegation against the accused is that after a quarrel with complainant Khalid Mehmood, they made firing at him and caused him injuries. Hence the present case.
- Today the complainant appeared before court and stated that he has compromised the matter with both the accused and forgiven them in the name of Almighty Allah, by waiving his rights of Arsh and Daman etc. Statement of complainant, in respect of compromise, was recorded in court and placed on file. The elder of locality, who appeared along with the complainant, endorsed the compromised as genuine and in best interest of the parties.
- 4. The offence u/s 324 PPC is compoundable. The complainant/injured has forgiven both the accused. In such a situation I do not see any reason to proceed any further with the instant trial. Resultantly, the compromise is accepted and both the accused facing trial, Gul Nawaz and Amir Nawaz, are acquitted in the present case, on the basis of compromise. They are on bail; their sureties are discharged from the liability of bail bonds.
- 5. Case property may be dealt with in accordance with law, after the expiry of period for appeal/revision. Let this file be consigned to Record Room after its completion and compilation.
