Petitioner No. 04 Abdul qudoos as attorney for rest of the petitioners along with counsel present. The petitioners seek succession certificate in respect of legacy of deceased namely Zahir Shah, who died on 25/03/2018. Arguments heard and record perused.

- Through publication in daily newspaper "Ausaf" dated; 16th 2. September, 2019 general public was asked to submit objections, if any, however, no one appeared before the court, so ex-parte proceedings were conducted.
- Petitioner No. 01 Rabia Jana Bibi, 02. Dost Muhammad, 03. Muhammad Raziq, 04. Abdul Qudooos 05. Amna Bibi 06. Rada 07. Shakila Naaz filed the instant application. Attorney of the petitioner recorded his statement as PW-1, while Aman Ullah as PW-2 and Nimat Khan as PW-3 testified respectively. PW-1 submitted his power of attorney as Ex. PW-1/1 and copy of his CNIC Ex.PW-1/2, copy of deceased CNIC is Ex. PW-1/6, copy of CNIC of petitioners No. 1 is Ex.PW-1/3, copy of CNIC of petitioners No. 2 is Ex.PW-1/4, copy of CNIC of petitioners No. 3 is Ex.PW-1/5, copy of CNIC of petitioners No. 5 is Ex.PW-1/6, copy of CNIC of petitioners No. 6 is Ex.PW-1/7, copy of CNIC of petitioners No. 7 is Ex.PW-1/8, , copy of death certificate of deceased as Ex. Original succession certificate be given to the petitioner subject to surety bonds while copy of the certificate be placed on file.
