Petitioner No. 5 Muhammad Umar as attorney for rest of the petitioners along with counsel present. The petitioners seek succession certificate in respect of legacy of deceased namely Inayat Ullah, who died on 31/08/2019. Arguments heard and record perused.

- 2. Through publication in daily newspaper "Ausaf" dated; 15th October, 2019 general public was asked to submit objections, if any, however, no one appeared before the court, so ex-parte proceedings were conducted.
- 3. Petitioner No. 01 Rapila Jan (widow), 02. Hashim Khela (Daughter), 03. Haroon Badshah (son), 04. Shahid Ullah (son) 05. Muhammad Umar (son) 06. Khadija Bibi (Daughter) 07. Bibi khatma 08. Jahanzeb 09. Abu Bakar filed the instant application. Fazal Khaiq, relative of the petitioners, recorded his statement as PW-1, while Salman as PW-2 and Muhammad Umar as PW-3 testified respectively. PW-3 attorney of the petitioners, submitted his power of attorney as Ex. PW-3/1 and copy of his CNIC as Ex.PW-3/2, copy of CNIC of petitioner No.1 as Ex. PW-3/3, copy of CNIC of petitioner No. 2 as Ex. PW-3/4, copy of CNIC of petitioner No.7 as Ex. PW-3/6, copy of CNIC of petitioner No. 4 as Ex. PW-3/7, copy of CNINC of petitioner No. 6 as Ex. PW-3/8, copy of death certificate of the deceased as Ex. PW-3/9 and bank statement as Ex.PW-3/10. All the

As, there is no other legal heir of deceased and considering the request of the petitioners being genuine this application is allowed along with accrued profit and Succession Certificate is issued in favour of petitioners, subject to surety bond/undertaking to the tune of Rs. 11 lacs with 02 local sureties each in the like amount to the satisfaction of this court. If any legal heir/objector appear in future, the petitioners and the sureties will be responsible for the payment. Parties are left to bear their own cost. Original succession certificate be given to the petitioner subject to surety bonds while copy of the certificate be placed on file.
- 6. File be consigned to the Record Room after its necessary completion and compilation.
