

## IN THE COURT OF MUHAMMAD AYAZ KHAN, SENIOR CIVIL JUDGE. ORAKZAI AT BABER MELA

Attorney Wahid Ullah for rest of the petitioners along with counsel present. The petitioners seek succession certificate in respect of legacy of deceased namely Ghani Shah, who died on 11/08/2019. Arguments heard and record perused.

- 2. Through publication in daily newspaper "Ausaf" dated; 11<sup>th</sup> January, 2020 general public was asked to submit objections, if any, however, no one appeared before the court, so ex-parte proceedings were conducted.
- 3. Petitioner No. 01 Mst Shoaib Khela (widow), 02. Wahid Ullah (Son), 03. Ziarat Khela (Daughter), 04. Sartaj Bibi (Daughter) 05. Muhammad Tariq (Son) 06. Imrana Bibi (Daughter) 07. Saima Bibi 08. Ihsan Ullah 09. Muhammad Amir 10. Arif Ullah filed the instant application. Wahid Ullah (attorney) recorded his statement as PW-1, Saif Ullah as PW-2 and Gulan Khan as PW-3 testified respectively. PW-1 submitted his power of attorney as Ex.PW-1/1, copy of his CNIC as Ex.PW-1/2, death certificate as Ex.PW-1/3 and Ex.PW-1/4, bank statement as Ex.PW-1/5, birth certificates of minor as Ex.PW-1/6 and 1/7, copy of CNIC of the petitioner No.1 as Ex.PW-1/8, petitioner No.3 to 05 CNICs as Ex.PW-1/9 to 1/11 and pension Book of the deceased as Ex.PW-1/12. All the exhibited documents, publication and report of process server etc. are placed on file. Contents of the petition were reproduced and verified by the witnesses.
- 4. As, there is nothing in rebuttal, so therefore contention of the petitioners is believed to be correct. Therefore, the petitioners will inherit

As, there is no other legal heir of deceased and considering the request of the petitioners being genuine this application is allowed along with accrued profit and Succession Certificate is issued in favour of petitioners, subject to surety bond/undertaking to the tune of Rs. 100,000 with 02 local sureties each in the like amount to the satisfaction of this court. If any legal heir/objector appear in future, the petitioners and the sureties will be responsible for the payment. Parties are left to bear their own cost. Original succession certificate be given to the petitioner subject to surety bonds while copy of the certificate be placed on file.
- 6. File be consigned to the Record Room after its necessary completion and compilation.
