Petitioner No.5 Muhammad Ibrahim as attorney for rest of the petitioners along with counsel present. The petitioners seek succession certificate in respect of legacy of deceased namely Nadar Khan, who died on 18/12/2019. Arguments heard and record perused.

- 2. Through publication in daily newspaper "Ausaf' dated; 5<sup>th</sup> February, 2020 general public was asked to submit objections, if any, however, no one appeared before the court, so ex-parte proceedings were conducted.
- 3. Petitioner No. 01 Mst Musafir Jan Bibi (widow), 02. Muhammad Usman (Son), 03. Muhammad Asim (son), 04. Abdullah (son) 05. Muhammad Ibrahim (Son) 06. Bismillah Khan (son) 07. Rab Nawaz (son) 08. Mst Noor Marjan (Daughter) 09. Mst Shaheen Bibi (Daughter) 10. Mst Sakeena Noor (Daughter) filed the instant application. Muhammad Ibrahim (attorney) recorded his statement as PW-1, Farman Ullah as PW-2 and Amjad Akhtar as PW-3 testified respectively. PW-1 submitted his power of attorney as Ex.PW-1/1, copy of his CNIC as Ex.PW-1/2, CNIC of Mst Musafir Jan as Ex.PW-1/3, form-B of the minor petitioners as Ex.PW-1/4, CNICs of major petitioners as Ex.PW-1/5 to 1/9, death certificate of the deceased as Ex.PW-1/10 and bank statement as Ex.PW-1/11. All the exhibited documents, publication and report of process server etc. are placed on file. Contents of the petition were reproduced and verified by the witnesses.

4. As, there is nothing in rebuttal, so therefore contention of the petitioners is believed to be correct. Therefore, the petitioners will inherit

Original succession certificate be given to the petitioner subject to surety bonds while copy of the certificate be placed on file.
