SUIT FOR DECLARATION, PERMANENT & MANDATORY INJUNCTION

JUDGEMENT:

Raza s/o Sarwan Ali, has brought the instant suit for declaration, permanent and mandatory injunction against the defendants, referred hereinabove, seeking declaration, therein, that his correct date of birth is 25.04.2003 while defendants have wrongly mentioned the same in their record as 08.06.2008, which is incorrect and liable to be corrected. Hence, the present suit.

Defendants were summoned, who appeared through attorney namely Syed Farhat Abbas and submitted written statement, wherein they contested the suit of plaintiff on various grounds.

Divergent pleadings of the parties were reduced into the following issues;

Issues:

- 1. Whether plaintiff has got cause of action?
- 2. Whether the correct date of birth of the plaintiff is "25.04.2003" while defendants have wrongly mentioned the same as 08.06.2008 in their record?
- 3. Whether plaintiff is entitled to the decree as prayed for?
- 4. Relief.
- 5. Parties were provided opportunity to produce evidence in support of their respective contention, which they did. Plaintiff produced his witnesses as PW-1 to PW-3.

In rebuttal defendants produced their sole witness namely Syed Farhat Abbas, representative, as DW-1. He produced the record form of plaintiff and exhibited the same as Ex. DW-1/1.

After conclusion of the evidence arguments pro and contra heard. Case file is gone through.

8. My issues wise findings are as under:

Issue No.02:

Plaintiff contended in his plaint that his correct date of birth is 25.04.2003 but inadvertently the same was erroneously recorded as 08.06.2008 in NADRA record. Hence, the record is liable to be corrected.

Plaintiff in support of his contention has appeared as PW-1 and he repeated the contents of plaint in his examination in chief. He also produced his Form-B as Ex.PW-1/1, matric certificate and DMC as Ex.PW-1/2 and Ex.PW-1/3, while PW-2, Mohsin Ali, who is real brother of plaintiff stated in his

examination in chief that correct date of birth of the plaintiff is 25.04.2003. PW-3, Rahmeen Ali, who is paternal uncle of the plaintiff also supported the contention of the plaintiff. He produced and exhibited his CNIC as Ex.PW-3/1. PW-1 to PW-3 were subjected to cross examination but nothing substantial was brought on record which could have shattered their testimony rather they remained consistent regarding the facts uttered by them in their examination in chief. Their testimony is also corroborated by the Matric certificate and Matric DMC of plaintiff produced by PW-1 as Ex.PW-1/2 and 1/3, wherein, the date of birth of plaintiff has been recorded as 25.04.2003. So, the oral and documentary evidence produced by the Polaintiff clearly establishing that the correct date of birth of the plaintiff is 25.04.2003. The incorporation of date of birth of the plaintiff as 08.06.2006 in the record of NADRA appears to be a mistake. Hence, the issue No. 2 is decided in positive.

Issue No. 01 & 03:

These issues are taken together. For what has been held in issue No. 2, this court is of the opinion that plaintiff has got cause of action and he is entitled to the decree as prayed for.

The issues are decided in positive.

Relief:

Consequently, suit of the plaintiff succeeds and is hereby decreed as prayed for. Defendants are directed to correct their

record by incorporating the date of birth of the plaintiff as 25.04.2003 in their record. Parties are left to bear their own costs.
