Ghulam Jafar (attorney) recorded his statement as PW-1, Hamid Raza as PW-2 and Syed Nabi Ali Shah as PW-3 testified respectively. PW-1 submitted his CNIC as Ex.PW-1/1, Power of attorney as Ex.PW-1/2, copy of CNIC of deceased as Ex.PW-1/3, copy of CNIC of widow of deceased as Ex.PW-1/4, copy of CNIC of Nazia Hassan as Ex.PW-1/5, Form-B of Minors as Ex.PW-1/6, Bank Statement as Ex.PW-1/7 and Ex.PW-1/8, death certificate of deceased as Ex.PW-1/9 and Ex.PW-1/10. All the exhibited documents, publication and report of process server etc. are placed on file. Contents of the petition were reproduced and verified by the witnesses.


