1. Petitioners through attorney Muhammad Zaman and through counsel present. The petitioners seek succession certificate in respect of legacy of deceased namely Ziarat Gul, who died on 09/11/2019. Arguments heard and record perused.

2. Through publication in daily newspaper "Ausaf" dated; 14th December, 2019 general public was asked to submit objections, if any, however, no one appeared before the court, so ex-parte proceedings were conducted.

3. Petitioner No. 01. Mst Khial Peeza (widow), 02. Muhammad Tariq (Son), 03. Muhammad Zahoor (Son) 04. Hameeda Bibi (Daughter) 05. Muhammad Jameel (Son) 06. Hazrat Bilal (Son) 07. Sadia Bibi (Daughter) 08. Hazrat Bibi (Daughter) filed the instant application. Muhammad Zaman (attorney) recorded his statement as PW-1, Taj Gul as PW-2 and Muhammad Khan as PW-3 testified respectively. PW-1 submitted power of attorney as Ex.PW-1/1, his CNIC as Ex.PW-1/2, Death certificate of deceased Ziarat Gul as Ex.PW-1/3, death notification certificate of deceased as Ex.PW-1/4, Residence cancellation card as Ex.PW-1/5, CNIC of deceased as Ex. Pw-1/6, passport of deceased as Ex.PW-1/7, deceased insurance etc. slip as Ex.PW-1/8, CNIC of petitioner No.2 as Ex.PW-1/9 and Form-B of minor petitioners as Ex.PW-1/10. All the exhibited documents, publication and report of process server etc. are placed on file. Contents of the petition were reproduced and verified by the witnesses.



If any legal heir/objector appear in future, the petitioners and the sureties will be responsible for the payment. Parties are left to bear their own cost. Original succession certificate be given to the petitioners' subject to surety bonds while copy of the certificate be placed on file.
