



**SUIT FOR DECLARATION & PERMANENT INJUNCTION**

**SUMMARY JUDGEMENT:**  
**ORDER XV-A CPC**

1. Plaintiff, **Muhammad Rehman s/o Gul Khan**, has brought the instant suit for declaration-cum-permanent injunction against the defendants, referred hereinabove, seeking declaration therein that his correct father's name is "**Gul Khan**" while it has been wrongly mentioned as "**Injeer Khan**" by the defendants, which is against the facts and circumstances. Hence, the instant suit.
2. Defendants were summoned, who appeared through attorney namely **Syed Farhat Abbas**, who stated at the bar that there is no need of filing of application on behalf of the defendants. He submitted written statement, which is placed on file.

During the scheduling conference within the meaning of order IX-A of CPC, it was revealed that the matter involved in the instant case is very petty in nature, which can be decided as per available record and there is no need of pro and contra evidence in the instant case. The primary aim and objective of recent Amendment Act 2019 in CPC is, "to enable the court to-

- a. Deal with the cases justly and fairly;
- b. Encourage parties to alternate dispute resolution procedure if it considers appropriate;
- c. Save expense and time both of courts and litigants; and
- d. Enforce compliance with provisions of this Code."

In scheduling conference, as per available record, the correct father's name of the plaintiff is **Gul Khan**, which has been wrongly mentioned by the defendants as "**Injeer Khan**".

The same factum is even evident from the CNICs of the siblings of the plaintiff namely Umar Khan, Muhammad Amin, Khaista Muhammad, Akbar Khan, Khan Muhammad and Taj Muhammad, wherein the father name is mentioned as **Gul Khan**. Further, Domicile Certificate of the plaintiff, copy of which are present on file, also verify the same factum. No need of evidence in the instant case. Hence, the claim of the plaintiff is proved as per the available documents and record, which are admissible in evidence.




