## SUIT FOR DECLARATION, PERMANENT & MANDATORY INJUNCTION

# **JUDGEMENT**:

15.10.2020

Brief facts of case in hand are that the plaintiff, Nazim Ali s/o Zigham Ali, has brought the instant suit for declaration, permanent and mandatory injunction against the defendants, referred hereinabove, seeking declaration, therein, that his correct date of birth is 02.02.1985 while defendants have wrongly mentioned the same in their record as 01.01.1982, which is incorrect and liable to be corrected. Hence, the present suit.

Defendants were summoned, who appeared through attorney namely Syed Farhat Abbas and submitted written statement, wherein they contested the suit of plaintiff on various grounds.

Divergent pleadings of the parties were reduced into the following issues;

- 1. Whether plaintiff has got cause of action?
- Whether the correct date of birth of the plaintiff is "02.02.1985" while defendants have wrongly mentioned the same as 01.01.1982 in their record?
- 3. Whether plaintiff is entitled to the decree as prayed for?
- 4. Relief.

- 5. Parties were provided opportunity to produce evidence in support of their respective contention, which they did. Plaintiff produced his witnesses as PW-1 and PW-4.
  - In rebuttal defendants produced their sole witness namely Syed Farhat Abbas, representative, as DW-1. He produced the record form of plaintiff and exhibited the same as Ex. DW-1/1.

After conclusion of the evidence arguments pro and contra , 30<sup>30</sup> heard. Case file is gone through.

My issues wise findings are as under:

## Issue No.02:

Plaintiff contended in his plaint that his correct date of birth is **02.02.1985** but inadvertently the same was erroneously recorded as **01.01.1982** in NADRA record. Hence, the record is liable to be corrected.

Plaintiff in support of his contention has appeared as PW-1 and he repeated the contents of plaint in his examination in chief. He also produced his school record as 5<sup>th</sup> class certificate as Ex.PW-1/2. PW-2, Ishtiaq Ali, who is maternal uncle of plaintiff stated in his examination in chief that correct

date of birth of the plaintiff is 02.02.1985. PW-3, Gul Fida Jan, who is mother of plaintiff stated in her examination in chief that correct date of birth of the plaintiff is 02.02.1985. PW-4, Naib Khan Khurram, who is SST teacher of Government High School, stated in his examination in chief that correct date of birth of the plaintiff according to school record is 02.02.1985. He produced the school record of the plaintiff as Ex.PW-4/1. PW-1 and PW-4 were subjected to cross examination but nothing substantial was brought on record which could have shattered their testimony rather they remained consistent regarding the facts uttered by them in their examination in chief. Their testimony is also corroborated by the School  $\sim$   $3^{\circ}$   $3^{\circ}$  PW-1 and PW-4 as Ex.PW-1/2 and Ex.PW-4/1 wherein, the date of birth of -1 the oral and documentary evidence produced by the plaintiff clearly establishing that the correct date of birth of the plaintiff is 02.02.1985. The incorporation of date of birth of the plaintiff as 01.01.1982 in the record of NADRA appears to be a mistake. Hence, the issue No. 2 is decided in positive.
