None present for the state. Learned counsel for accused/petitioner present. Injured/complainant Zakir Ullah along with father namely Ameen Badshah present. Elder/jirga member Niaz Buhadar and Khial Afzal, elder of the family present. Record received.

Counsel for accused/petitioner submitted application to the effect that section 15-AA is inadvertently not mentioned in the bail petition and requested for its insertion. Record shows that after recovery of one pistol 30 bore along with 02 cartridges of the same bore on the pointation of accused/petitioner, section 15-AA was added in the record, hence, application is allowed. Section 15-AA inserted in the bail petition with red ink.

Injured/complainant Zakir Ullah and his father namely Ameen Badshah, stated at the bar that they have patched up the





matter with accused/petitioner and have got no objection if accused/petitioner is released on bail or subsequently acquitted. Joint statement of injured/complainant namely Zakir Ullah and his father namely Ameen Badshah is separately recorded which was duly thumb impressed by them. Photocopy of CNIC of Ameen Badshah is Ex-PA. Joint statement was duly endorsed by Khan Afzal (Elder of the family) and Niaz Buhadar Khan (Jirga member).

Accused/petitioner namely Asif Nawaz S/O Noor Zali Shah is seeking his post arrest bail in case FIR No. 65, Dated: 21.06.2023 U/S 324/34 PPC and 15-AA, PS Kalaya, Orakzai.

The offence u/s 324 PPC for which accused/petitioner is charged is compoundable in nature while section 15-AA is bailable. Complainant party has categorically stated in their joint statement that they have entered into compromise with accused/petitioner and have pardoned them in the name of Almighty Allah and have got no objection on the release of accused/petitioner on bail or his subsequent acquittal, resultantly, application in hand is allowed. Petitioner be released on bail subject to furnishing bail bonds in the sum of Rs. 50,000/- with two sureties each in the like amount to the
