# SUIT FOR DECLARATION & PERMANENT INJUNCTION

## SUMMARY JUDGEMENT 12.06.2023

Plaintiff along with counsel present. Mr. Irfan Hussain, Superintendent/legal representative of defendants also present. Authority letter, written statement and NADRA record of plaintiff submitted. Counsel for plaintiff requested for summary disposal of the suit on the basis of available record. Representative of defendants stated that he has got no objection on the summary disposal of the case. Arguments heard and record perused.

Brief facts in the backdrop are that plaintiff Mst. Zulqida Jan has filed the instant suit for declaration cum-permanent injunction against the defendants Chairman NADRA, Islamabad and two others

to the effect that correct name of her father is Zafar Ali and her correct mother's name is Basmina Jan however, defendants have incorrectly entered her father's name as Rashid Ali instead of Zafar Ali and her mother's name as Zafrana Jan instead of Basmina Jan which entries are wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. It is further averred that Rashid Ali and Zafrana Jan are the parents of her husband and are parents-in-law of plaintiff. That defendants were asked time and again to rectify the record but in vain hence, the present suit.

With due process of law and procedure, the defendants were summoned, they appeared through representative. Authority letter was submitted. Written statement was also filed.

Legal representative of defendants produced NADRA record of plaintiff as per which father's name of her husband is recorded as Rashid Ali and her mother's name as Zafrana Jan. Per NADRA record, father's and mother's name of Hakmeen Ali is also recorded as Rashid Ali and Zafrana Jan which means that they are parents-in-law of plaintiff. Legal representative of defendants also affirmed this fact. Copy of domicile certificate of plaintiff is also placed on file wherein, her husband's name is recorded as Hakmeen Ali. Therefore, there is no need of recording evidence of the parties. Legal representative of defendants stated that per NADRA SOPs, the modification/rectification sought by plaintiff could be made accordingly. Resultantly, suit of plaintiff is hereby decreed as prayed
