file as deep appreciation of case file is neither required nor warranted at this stage. The accused/petitioner was allegedly carrying chars and was arrested on the spot. The huge quantity of 9000 grams of chars as well as Pistol and live rounds were allegedly recovered from the trouser fold which was in the direct possession of accused that has been supported with ocular evidence of the witnesses recorded on memorandum of recovery. The parcel separated for the purpose of examination through channel of Forensic Science Laboratory have promptly been sent. The huge quantity apparently rules out the chance of false implication. The case of accused/petitioner is also falling within the ambit of prohibitory Clause of Section-497 of Procedure Code. Criminal 1898. accused/petitioner on the spot and recovery of chars and arms connect the accused/petitioner with the commission of offence on its face and thus the Court is not inclined to extend him concession of bail.
