

APP for the state present. Accused on bail present. Complainant and Injured in person present.

The Complainant/Injured namely Muhammad Sadiq and Nasir Khan sons of Khaistan Shah have already recorded their joint statement of compromise on previous date whereby they stated that they have effected compromise with the accused and have pardoned them in the name of Almighty Allah. They further stated that they have got no objection on the acquittal of the accused. Copies of their CNICs are Ex.PA and Ex.PB. Joint Statement of complainant and injured recorded in context of compromise.

The offence u/s 324/34 PPC is compoundable. The compromise seems genuine and is in the best interest of both the parties, same is therefore accepted to the extent of sec. 324/34 PPC and accused facing trial are acquitted from the charges levelled against them. They are on bail. Their bail bonds stand cancelled and sureties are discharged from

the liability of bail bonds while to the extent of offence u/s 15AA, the accused facing trial submitted, an application for plead guilty which is accepted. As accused pleaded their guilt, therefore, there is no need of recording of evidence against the accused as per available record on file and clear admission, the accused being first offender are repentant of their guilt, therefore, I hereby convict the accused and sentence them to suffer simple imprisonment for a period of 03 years.

Since the accused are first offenders and there is nothing on file to reflect upon their character. Therefore, instead of sentencing them at once, the lenient view is taken and is deemed just and proper to require them to be under supervision of District Probation Officer u/s 5 of the probation of offender's ordinance 1960 for a period of 03 years subject to furnishing bail bonds to the tune of Rs. 80,000/- with two local and reliable sureties each in the like amount to the satisfaction of Probation

Officer concerned for keeping peace and good behavior and also repeating of the same offence for said period. The Probation Officer shall deal with the convict in accordance with law and shall keep strict supervision of the movements and behavior of the convicts for the said period.



In case of default or violation, the accused shall be committed to undergo simple imprisonment for a period of 03 years. He shall ensure good behavior during the tenure of the probation of the convicts. Copy of the order be sent to Probation Officer, Orakzai alongwith accused and sureties.

*Case property being Kalashnikov alongwith 01 fixed charger and 03 rounds of 7.62 bore and one knife are hereby confiscated to the state and be dealt in accordance with law. The remaining case property be dealt in accordance with law subject to period of appeal/revision.*
