That he shall not repeat the offence. 1. 2. That he shall keep and maintain peace and order in the society. That he must exhibit good behavior during the prescribed period of 3. probation. That he shall appear before the probation officer once in a month, 4. which date is left to the discretion of the probation officer to be fixed. That he shall not leave the country without permission of probation 5. officer. 6. That if he violates the above conditions, the bonds will be recalled and he will be proceeded in accordance with the provision of the Ordinance ibid. That in case of default by the convict, the direction regarding 7.

probation shall stand recalled and convict shall undergo imprisonment accordingly.
