Accused/petitioners namely Muhammad Younas, Naseem Ullah and Rafi Ullah Ss/O Ameen Badshah are seeking their post arrest bail in case FIR No. 65, Dated: 21.06.2023 U/S 324, 337 A(i)/34 PPC and 15-AA, PS Kalaya, Orakzai.

Although, accused/petitioners are directly and by name charged in cross version report recorded vide mad No. 10 dated 21.06.2023 and the punishment for the offence U/S 324 PPC falls within the ambit of prohibitory clause of Section 497 Cr. PC however, record shows that no empty has been recovered from the specific role attributed spot. has been accused/petitioners. It is a case of ineffective firing. Nothing incriminating has been recovered from possession of the accused/petitioners or on their pointation. Furthermore, there is which nothing record could show that accused/petitioners are previously convict or habitual, hardened, desperate or dangerous criminals. Participation of accused/petitioners in the commission of the offence is to be determined during trial. Co-accused namely Ali Mat Shah has already been released on bail on the basis of compromise with the complainant party vide order dated 27.06.2023. Investigation has already been completed and accused/petitioners are no more required to the local police for further investigation and no useful purpose would be served by keeping the accused/petitioners behind the bar.

Consequently, application in hand is allowed. Petitioners be released on bail subject to furnishing bail bonds in the sum of Rs. 50,000/- (Fifty thousand) with two sureties each in the like amount
