

Order No 05 continued	07.09.2023	<p>The record shows that the above-mentioned Naqalmad is cross version of FIR No. 18, Dated: 24.08.2023, u/s 324, PPC, registered in PS Ghiljo U/Orakzai. The present accused/petitioners have not been charged for making firing rather accused Mujeeb has been given the role of effective firing. It cannot be determined at this stage that who was the aggressor and who was agressed upon. Furthermore, counsel for the complainant Noor Mir Jan advocate conceded in favour of the petitioners and in this connection statement of Muhammad Bakhtiar brother of the injured/complainant Rizwan is recorded wherein he stated that the complainant being injured is admitted in hospital and cannot attend the court for recording his statement. His statement is verified by Noor Mir Jan advocate.</p> <p>In view of the said statement, I hereby accept the present application.
