**SUIT FOR DECLARATION & PERMANENT INJUNCTION****JUDGEMENT**

15.08.2023

Through this judgement, I am going to dispose of the instant suit filed by plaintiff namely Mst. Hunar Pari and two others against defendants Chairman NADRA, Islamabad and two others for declaration and permanent injunction.

Brief facts as per plaint are that correct father's name of plaintiff No. 1 is Mir Jad Ali whereas defendants have incorrectly and wrongly entered the same in CNIC as Mir Chad Ali. It is further averred that correct mother's name of plaintiff No. 2 and plaintiff No. 3

is Faida Jan (فائده جان) whereas defendants have incorrectly and wrongly entered the same as Paida Jan (پياده جان) in their official record which entries are wrong, illegal and ineffective upon the rights of plaintiffs and liable to be rectified. That defendants were asked time and again to do the needful but in vain, hence the present suit.

After institution of the suit, defendants were summoned, who marked their attendance through representative and contested the suit by filing authority letter and written statement.

From divergent pleadings of the parties, the following issues were framed for adjudication of real controversy between the parties. The controversial pleadings of the parties were reduced into the following issues:

### ISSUES

1. Whether plaintiffs have got cause of action? OPP
2. Whether suit of plaintiffs is within time? OPP
3. Whether correct father's name of plaintiff No. 1 is Mir Jad Ali instead of Mir Chad Ali? OPP
4. Whether correct mother's name of plaintiff No. 2 and plaintiff No. 3 is Faida Jan (فائده جان) instead of Paida Jan (پياده جان)? OPP
5. Whether plaintiffs are entitled to the decree as prayed for? OPP
6. Relief.

Upon submission of list of witnesses, both the parties on being provided with an opportunity to adduce their desired evidence, the parties produced their respective evidence.

After the completion of evidence, arguments of the learned counsels for the parties were heard and record of the case file was gone through with their valuable assistance.

Plaintiffs produced two witnesses in support of their claim while defendants produced one witness in defense.

Kamal Shah, special attorney of plaintiffs appeared and recorded his statement as PW-01. He supported plea of plaintiffs. Special power of attorney is Ex. PW-1/1, copy of his CNIC is Ex. PW-1/2.


Misbah Ali, brother of plaintiffs appeared and deposed as PW-02. He fully supported the claim of plaintiffs. Copy of his CNIC is Ex. PW-2/1.

Thereafter, evidence of plaintiffs was closed.

Nothing contradictory could be brought on record from the statements of PWs.

Irfan Hussain (Representative of NADRA, Orakzai) appeared as DW-01. He produced family trees of plaintiffs, which are Ex. DW-1/1, Ex. DW-1/2 and Ex. PW-1/3. He stated that plaintiffs were issued CNICs as per information provided by them and that they have got no cause of action and lastly requested for dismissal of suit.

Thereafter, evidence of defendants was closed.

The above discussion boils down to my following issue-wise findings.

**ISSUE NO.2**

Plaintiffs have been issued CNICs on 22.09.2022, 13.08.2015 and 30.08.2019 with expiry dates as 22.09.2032, 13.08.2025 and 30.08.2029. Suit in hand was filed on 05.08.2023. As period of limitation under Article 120 of Limitation Act is six years, therefore, suit of plaintiffs is held to be within time. Issue No. 2 decided in positive.

**ISSUES NO.3 & 4**

Both these issues are interlinked, therefore, taken together for simultaneous discussion.

Claim and contention of plaintiffs is that correct father's name of plaintiff No. 1 is Mir Jad Ali whereas defendants have incorrectly and wrongly entered the same as Mir Chad Ali. It is further averred that correct mother's name of plaintiff No. 2 and plaintiff No. 3 is Faida Jan (فائده جان) whereas defendants have incorrectly and wrongly entered the same as Paida Jan (پياده جان) in their official record which entries are wrong, illegal and ineffective upon the rights of plaintiffs and liable to be rectified.

Plaintiffs produced cogent, convincing and reliable documentary as well as oral evidence in support of their claim and

contention. Even, record produced by DW-01 in shape of Ex.DW-1/1 and Ex.DW-1/3 support the plea of plaintiffs. DW-01, in his cross examination, admitted that the modification sought by plaintiffs will not affect family trees of plaintiffs.

Keeping in view the above discussion, documentary as well as oral evidence available on file, issues No. 3 & 4 decided in favour of plaintiffs and against the defendants.

**ISSUES NO.1 & 5.**


In the light of foregoing discussion, plaintiffs have proved their stance through cogent, convincing and reliable documentary and oral evidence, therefore, They have got cause of action and are entitled to the decree, as prayed for. Both these issues are decided in positive in favor of plaintiffs.

**RELIEF:**

Crux of my issue wise discussion is that suit of the plaintiffs is hereby decreed in their favor against the defendants as prayed for. No order as to cost. This decree shall not affect the rights of other persons interested, if any.


