Brief facts in the backdrop are that plaintiff Ali Rehman has

wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That defendants were asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.

With due process of law and procedure, the defendants were summoned, they appeared through representative. Authority letter was submitted. Written statement was also filed.

Record shows that plaintiff has placed reliance on secondary school certificate, per which, date of birth of plaintiff is recorded as 01.03.2007. Representative of defendants stated that date of birth of plaintiff may be modified as per school record per NADRA SOPs. Copy of school certificates of plaintiff are annexed with plaint. Presumption of correctness is attached to the entries in the secondary school certificates. There is no need of recording evidence of the parties.
