SUIT FOR DECLARATION, CUM PERPETUAL AND MANDATORY INJUNCTION

SUMMARY JUDGEMENT: 24.02.2021

Brief facts of the case in hand are that the plaintiff,

Muhammad Umar S/O Abdul Wali has brought the instant suit for declaration cum perpetual and mandatory injunction the defendants, referred hereinabove, seeking against \mathcal{D} declaration therein that his correct date of birth is 01.08.2004according to his Matric Certificate/DMC, while it has been preficial et (Bryot Kela) wrongly mentioned as 22.03.2001 in his CNIC by the defendants, which is wrong, ineffective upon the rights of the plaintiff and liable to correction. That defendants were repeatedly asked to correct the date of birth of plaintiff but they refused, hence, the instant suit.

- 2. Defendants were summoned, who appeared through their representative namely Syed Farhat Abbas, who submitted written statement.
- 3. During the scheduling conference within the meaning of order IX-A of CPC, it was revealed that the matter involved in the instant case is very petty in nature, which can be decided through summary judgement as per relevant record. To this effect notice was given to the parties that why not the case in hand be decided on the basis of available record without recording lengthy evidence, as the primary aim and objective of Amended Management Rules in CPC is, "to enable the court to
 - a. Deal with the cases justly and fairly;
 - b. Encourage parties to alternate dispute resolution procedure if it considers appropriate;
 - c. Save expense and time both of courts and litigants; and
 - d. Enforce compliance with provisions of this Code."

Learned counsel for plaintiff and representative for defendants heard and record gone through.

4. Record reveals that plaintiff through instant suit is seeking correction of his date of birth to the effect that his correct date of birth is 01.08.2004 according to his Matric Certificate/DMC while it has been wrongly mentioned as 22.03.2001 in his CNIC by the defendants, which is wrong, ineffective upon the rights of the plaintiff and liable to

correction. Plaintiff in support of his contention produced the copy of his Matric Certificate/DMC wherein the date of birth of the plaintiff has been mentioned as 01.08.2004. So, the said document clearly negates the incorporation of his date of birth as 22.03.2001 in his CNIC. Further, there is no countered document available with the defendants to rebut the document produced by the plaintiff in support of his contention. Hence, in these circumstances, the said documents are admissible and reliance is placed on it and are sufficient to decide the fate of the case and no further evidence is required to be produced by the parties. So, the available record clearly establishes the claim of the plaintiff.

- 5. Consequently, upon what has been discussed above and the jurisdiction vested in this court under order IX-A and XV-A of CPC, suit of the plaintiff succeeds and is hereby decreed as prayed for. Defendants are directed to correct the date of birth of plaintiff as **01.08.2004** in their record and in the CNIC of the plaintiff.
- 6. Parties are left to bear their own costs.
- 7. File be consigned to the record room after its necessary completion and compilation.
