(1)- Brief facts of the case are that Accused namely **Eid Rehman** S/O Bait Ullah CNIC no. 21508-5694372-5 DOB 01.01.1965 R/O Tribe Papali, Sub Tribe Qabil Khel, PO Shiwa, Tehsil Shiwa, District North Waziristan is charged in case FIR no. 04, dated 15.01.2020, U/S and 15AA KP Police station Ghiljo, Upper Orakzai for carrying weapon Kalashnikov with 12 bullets of 7.62 bore without valid license/permit.

(2)- Today, accused submitted an application wherein, he requested that his case be decided on basis of his pleading guilty. To this effect his statement was recorded wherein he has admitted his guilt. A Show cause notice U/S 243 Cr.P.C was served upon accused to show as to why he should not be convicted under the relevant sections of law. To this notice, he replied that he is a first offender and committed an offence due to having personal enmity. He is repentant. He requested for court mercy.

(3)- Taking into considerations the application and plea of the accused, he is entitled to be dealt with leniency. Therefore, considering all the facts of the case; the accused **Eid Rehman** S/O Bait Ullah is **convicted** under section 15AA; but in order that the accused may be reformed and he became a useful citizen of state, instead of serving any term of imprisonment, it is directed that he be released on **probation** for a terms of **three years**. The accused is also liable to pay a fine of Rs.500/-. The accused paid the fine in court today.

- (4)- The accused/convict is directed to submit before the Probation Officer of District Orakzai surety bonds from two local and reliable sureties in the sum of Rs. 100,000/- each to the satisfaction of Probation Officer, Orakzai today.
- (5)- The convict shall also submit an undertaking to the Probation Officer to the effect that he would remain peaceful, law abiding, civic and a beneficial citizen of the country and that he would follow all instructions given by the probation officer from time to time. In case of any violation of these terms or any adverse complaint against the accused by the Probation Officer, this probation order shall stand revoked and the convict would become liable to undergo imprisonment of suitable term. Copy of this order shall also be sent to Probation Officer for further necessary action.
- (6)- Case property one Kalashnikov full bat number 195\*56163 along with 12 live bullets of 7.62 bore stands confiscated to the state. File be consigned to record room after necessary completion and compilation.
