

## IN THE COURT OF FARMAN ULLAH

- 1. Petitioners through attorney Noor Zameer and through counsel present. The petitioners seek succession certificate in respect of legacy of deceased namely Awal Meer, who died on 15/09/2020. Arguments heard and record perused.
- 2. Through publication in daily newspaper "Ausaf" dated; 04<sup>th</sup> December, 2020 general public was asked to submit objections, if any, however, no one appeared before the court, so ex-parte proceedings were conducted.
- 3. Petitioner No. 01. Mst Marjan Bibi (widow), 02. Noor Zameer (Son) and 03. Mst Eid Marjana (doughter) filed the instant application. Gul Maan Shah recorded his statement as PW-1, Eid Marjan PW-2 and Noor Zameer (attorney) as PW-3 testified respectively. PW-3 submitted power of attorney for Petitioners as Ex.PW-3/1, Copy of CNIC as Ex,PW-3/2, Death certificate of deceased Awal Meer as Ex.PW-3/3, Copy of CNIC of his Mother (Petitioner No.1) as Ex.PW-3/4, Copy of CNIC of his Sister (Petitioner No.3) as Ex.PW-3/5, Bank statement of account as Ex.PW-3/6, Copy of Serves Book as Ex.PW-3/7 and Copy of CNIC of deceased Awal Meer as Ex.PW-3/8. All the exhibited documents, publication and report of process server etc. are placed on file. Contents of the petition were reproduced and verified by the witnesses.
- 4. As, there is nothing in rebuttal, so therefore contention of the petitioners is believed to be correct. Therefore, the petitioners will inherit

As, there is no other legal heir of deceased and considering the request of the petitioners being genuine this application is allowed along with accrued profit and Succession Certificate is issued in favour of petitioners, subject to surety bond/undertaking to the tune of Rs. 200,000 with 02 local sureties each in the like amount to the satisfaction of this court. If any legal heir/objector appear in future, the petitioners and the sureties will be responsible for the payment. Parties are left to bear their own cost. Original succession certificate be given to the petitioners' subject to surety bonds while copy of the certificate be placed on file.
- 6. File be consigned to the Record Room after its necessary completion and compilation.
