

,		2. Arguments heard; whereas, this order is intended to
		dispose of the captioned Bail Application submitted by
		Accused/petitioners Feroz Khan son of Raza Khan, Shabir
		son of Feroz Khan and Faiz Ullah son of Khewa Khan, all
		resident of Naka Mela, District Orakzai.
		3. Shamal Khan son of Rehman Gul reported the matter
		of sustaining injuries by Shah Ayaz and his father Rahim
		khan being beaten by the accused while attempting the
		kidnaping, to the local police which was incorporated into
		Daily Diary No. 09 dated 30.04.2023. Rahim Khan
		(abductee) was recovered from the Hujra of accused and
		had been shifted to DHQ Mishti Mela. On receiving
		medico legal report (MLC), local police has referred the
		matter to District Public Prosecutor for opinion.
		Consequently, FIR bearing No.20 dated 22.06.2023 was
		registered under sections 337 F(iii)/ 365/148/149 of
		Pakistan Penal Code 1860, in Police Station Central Mishti
		Mela, Orakzai. Petitioners being behind the Bar as co-
		accused moved this Court with application for post arrest
;		bail which is under consideration.
		4. Arguments of counsel for the accused/petitioners,
		counsel representing complainant and APP for State heard
		and record perused.
		5. On tentative assessment of the record being stage of

FIR bearing NO.24 Dated 13.07.2023. One party (the



complainant of this case) has already been extended the concession of bail in BA.66/4 and thus the petitioners being second party is also entitled for the same relief; the principal which has been adopted in 2004 PCrLJ 127. Similarly, the case of counter version by itself can be stretched as valid ground of further inquiry. These facts sufficiently renders the case of petitioners as that of further inquiry. Moreso, there is no concept of withholding bail as matter of punishment; especially, where prohibition is not attracted.

- 6. In view of the above, the plea of bail is accepted. Consequently, the accused/petitioners are released on bail subject to furnishing surety bond in the sum of Rs. 120,000/- with two sureties, each in the like amount, to the satisfaction of this Court.
- 7. File of this Court be consigned to District Record Room, Orakzai after its necessary completion and compilation within the span allowed for. Record of the Police be sent back with copy of this Order.
