of the prosecution mentioned the fact that report has been lodged by the complainant as counter blast to minimize the strength of the case earlier registered by the accused is complainant against the complainant party of this case. These facts sufficiently renders the case of petitioners as that of further inquiry. Moreso, there is no concept of withholding bail as matter of punishment; especially, where prohibition is not attracted.

6. In view of the above, the plea of bail is accepted. Consequently, the accused/petitioners are released on bail subject to furnishing surety bond in the sum of Rs. 80,000/with two sureties, each in the like amount, to the satisfaction of this Court.

7. File of this Court be consigned to District Record Room, Orakzai after its necessary completion and compilation within the span allowed for. Record of the Police be sent back with copy of this Order.
