- Muhammad Younas SHO of Police Station Central Mishti Mela being complainant of the case appeared and stated at the bar that he is under instruction to have no objection over the acceptance of pending bail application as the matter has already been compromised. He presented written compromise (Ex.PA) and was examined on oath which confirms the fact of compromise genuinely effected between the parties. The Police being law enforcement agency and the accused being general public had patched up the matter through the intervention of the elders of locality and other stakeholders of District Administration and that is why being accepted in the best interest of justice.
- 5. For what has been discussed above, instant pre arrest bail petition stands allowed on the basis of compromise. Ad-interim pre arrest bail earlier granted to the accused/petitioners is hereby confirmed on existing bail bonds. File of this Court be consigned to District Record Room after its necessary completion and compilation within the span allowed for; whereas, copy of this Order be placed on record of Police to be returned accordingly.
