1. Petitioners through attorney Inam Ul Din and through counsel present. The petitioners seek succession certificate in respect of legacy of deceased namely Muzamil Shah, who died on 18/11/2020. Arguments heard and record perused.
2. Through publication in daily newspaper "Ausaf" dated; 14<sup>th</sup> January, 2021 general public was asked to submit objections, if any, however, no one appeared before the court, so ex-parte proceedings were conducted.
3. Petitioner No. 01. Mst Shereen Bibi (Widow), 02. Inam Ul Din (Son), 03. Noor Ul Hadi (Son) 04. Mst Khaista Mena (daughter), 05. Masood Rehman (Son), 06. Mehmood Rehman (Son) and 07. Original succession certificate be given to the petitioners' subject to surety bonds while copy of the certificate be placed on file.
