1. Petitioners through attorney Irfan Ullah and through counsel present. The petitioners seek succession certificate in respect of legacy of deceased namely Abdur Rehman, who died on 18/11/2020. Arguments heard and record perused.
2. Through publication in daily newspaper "Ausaf" dated; 19<sup>th</sup> December, 2020 general public was asked to submit objections, if any, however, no one appeared before the court, so ex-parte proceedings were conducted.
3. Petitioner No. 01. Mst Khyber Bibi (Widow), 02. Kamran Khan (Son), 03. Mst Nazia Bibi (Daughter) 04. Mst Noreen Bibi (Daughter), 05. Muhammad Imran (Son) and 06. Irfan Ullah (Son) filed the instant application. Said Hanif recorded his statement as PW-1, Abdul Aziz PW-2 and Irfan Ullah (Attorney) as PW-3 testified respectively. PW-3 submitted his CNIC as Ex.PW-3/1, attorney for petitioners as Ex,PW-3/2, death certificate of deceased as Ex.PW-3/3, bank statement as Ex.PW-3/4, CNIC of deceased as Ex.PW-3/5, CNIC of petitioner No.1 as Ex.PW-3/6, CNIC of petitioner No.2 as Ex.PW-3/7, CNIC of petitioner No.3 as Ex.PW-3/8. All the exhibited documents, publication and report of process server etc. are placed on file. Contents of the petition were reproduced and verified by the witnesses.
4. As, there is nothing in rebuttal, so therefore contention of the petitioners is believed to be correct. Therefore, the petitioners will inherit the legacy of deceased as per following shares;
