- 2. Through publication in daily newspaper "Ausaf" dated 20th Feb, 2021 general public was asked to submit objections, if any, however, no one appeared before the court, so ex-parte proceedings were conducted.
- 3. Petitioner No. 01. Mst Saeed Jahana (Widow), 02. Muhammad Ullah Jan (Father) 03. Mst Sher Namy (Mother) filed the instant application. Muhammad Shabib (attorney) recorded his statement as PW-1, Muhammad Hanif as PW-2 and Shahid Ullah as PW-3 testified respectively.
