- 1. Petitioners through attorney and counsel present. The petitioners seek succession certificate in respect of legacy of deceased namely Muhammad Khan, who died on 24/12/2020. Arguments heard and record perused.
- 2. Through publication in daily newspaper "Ausaf" dated; 06<sup>th</sup> March, 2021 general public was asked to submit objections, if any, however, no one appeared before the court, so ex-parte proceedings were conducted.
- 3. Petitioner No. 01. Mst Rokmila Jan (widow), 02. Ilm E Raza (Son), 03. Muhammad Raza (Son), 04. Haseena Bibi (Daughter) filed the instant application. Intizar Ali (attorney) recorded his statement as PW-1, Iftikhar Hussain PW-2 and Jaleel Hussain as PW-3 testified respectively. PW-1 submitted power of attorney for Petitioners as Ex.PW-1/1, Copy of his CNIC as Ex,PW-1/2, Death certificate of deceased as Ex.PW-1/3, CNIC of petitioner No. 1 as Ex. PW-1/4, Copy CNIC of deceased as Ex.PW-1/5, All the exhibited documents, publication and report of process server etc. are placed on file. Contents of the petition were reproduced and verified by the witnesses.
- 4. As, there is nothing in rebuttal, so therefore contention of the petitioners is believed to be correct. Therefore, the petitioners will inherit the legacy of deceased as per following shares;
