
1. Petitioner present through counsel.

Arguments heard and record gone through.

The petitioner seeks succession certificate in respect of legacy of deceased namely Ali Man Shah, who died on 06/11/2019.

- 2. Through publication in daily newspaper "Ausaf" dated; 22nd May, 2021 general public was asked to submit objections, if any, however, no one appeared before the court, so proceeded ex-parte.
- 3. Petitioner No. 01. Mst Bibi Janat Khela (widow), filed the instant application. Ihsan Ullah recorded his statement as PW-1, Saifoor Rehman as PW-2 and Mst Bibi Janat Khela as PW-03 testified respectively. PW-3 submitted her CNIC as Ex.PW-3/1, copy of death certificate of deceased as Ex.PW-3/2 and Power of attorney as Ex.PW-3/3, All the exhibited documents, publication and report of process server etc, are placed on file. Contents of the petition were reproduced and verified by the witnesses.
- 4. The available record on file prima facie establishes that petitioner and respondents No.2 to 5 are the legal heirs of deceased Ali Man Shah as there is nothing in rebuttal. Hence, petitioner along with respondents No.2 to 5 will inherit the legacy of deceased as per following shares;
