		2. This is the disposal of Post arrest bail application
		presented by accused/petitioner Lalgah Khan s/o Ali Sardar
		r/o Utman Khel Tappa Buzdan Khel Speen Dara, District
		Orakzai; charged in FIR No. 56 dated: 02/05/2021
		registered under Section 5 of the Khyber Pakhtunkhwa
		Control of Narcotics Substance Act, 2019.
		3. Mr. Taj Muhammad Khan Sub Inspector of Police
		Station Kalaya, Orakzai on getting spy information moved
		towards the property of the accused located at Speen Dara
		Orakzai and found gathering of Opium Poppy. Criminal
		Law was brought into motion against the accused and
		resultantly, FIR bearing No. 56 dated: 02/05/2021 was
		registered against the accused by attracting Section 5 of the
		KP Control of Narcotics Substances Act, 2019 in Police
		Station Kalaya of District Orakzai. The accused was
		arrested on spot who was later on remanded to Judicial
		Lockup. Consequently, application for release of accused
		on bail is presented which is under consideration.
		4. Learned counsel for accused/petitioner and learned
		Assistant Public Prosecutor for state were heard at length
		and file gone through.
		5. This is tentative assessment of record available on
		file and deep appreciation is neither necessary nor
		warranted. The accused/petitioner was charged for
		cultivation of Opium Poppy in landed property owned by
		him but it has nowhere been established that the property is
	1	his ownership. The statement of the Local Mashar/Malak

etc. for establishing ownership on face of it was required on part of the investigation which has not been done. The Opium Poppy allegedly recovered has been sent to FSL for forensic examination but the report is still awaited. No independent witnesses have been associated with the process. Similarly, no criminal history of the accused is available on file. The offence with which the accused has been charged is out of the ambit of prohibitory clause of 497 Criminal Procedure Code, 1898 as well. All these facts drag the case of accused/petitioner as matter of further inquiry.

6. For what has been discussed above, instant bail petition stands allowed subject to furnishing of bail bonds in the sum of Rupees 70,000; with two sureties, each in the like amount; to the satisfaction of this Court. File of this Court be consigned to District Record Room after its necessary completion and compilation within the span allowed for; whereas, copy of this Order be placed on record of Police to be returned accordingly.
