

Order -05 15.09.2023

Special attorney of petitioners along with counsel present. Court Fee submitted.

Arguments heard and record perused.

- 1. Petitioner Mst. Qamar Gulla (mother), Zainab Bibi (widow), Mst. Zeenat Bibi (daughter), Mst. Gulshan (minor daughter), Shaheen Akbar (minor son), Muhammad Abbas (minor son), Shah Zaman (minor son) and Irfan Ullah (minor son) all residents of Qoum Ali Khel, Tappa Sher Khel, Tehsil Upper, District Orakzai have filed the instant petition against respondents, public at large, for issuance of Succession Certificate in respect of LRs of deceased Rasool Akbar. According to the above-named petitioners, they are LRs of the deceased and there is no other legal heir except them.
- 2. Notice to respondents i.e., public at large was issued in daily newspaper "Aieen" dated 05.09.2023, but no one appeared before the court, so ex-parte proceedings were initiated against the respondents public at large. During ex-parte evidence, one Shahid Gul S/O Kamin Gul being special attorney of the petitioners appeared as PW-01. He produced the following documents.

- 3. All the exhibited documents, publication and report of process server etc are placed on file. Contents of the petition were reproduced and verified by the witnesses. The report of Naimat Ullah Process Server on notice for verification of LRs of deceased dated 05.09.2023 is also self-explanatory and is confirming the stance of the petitioners.

The available record on file prima facie establishes that petitioners are the legal heirs of deceased Rasool Akbar as there is nothing in rebuttal due to ex-parte. The list of legal heirs of deceased is as under;

4. As, there is no other legal heir of deceased and considering the request of the petitioners being genuine, this application is allowed. Therefore, Succession Certificate is hereby issued in favour of petitioners being LRs of the deceased according to their Sharia shares. The petitioners are directed to deposit surety bond to the tune of Rs. 800,000/- with 02 local sureties each in the like amount to the satisfaction of this court. Succession Certificate be issued on the stamp paper and copy of the same be placed on file. If any legal heir/objector appear in payment, the petitioners and the sureties will be responsible for the payment. Parties are left to bear their own cost.
